



Tuition and Fees

Cash Discounted Rate

Deposit - \$3000

Initial This deposit is due prior to a student's entrance into the program and is nonrefundable. A bed will not be reserved for the student until this deposit is received. This deposit will be applied to the student's tuition bill after he enters the program.

Tuition, Room, and Board - \$72,000 (\$54,000 with Full Payment Discount)

Initial Those paying the cash discounted rate pay one fee for the entire program. This fee covers up to 12 months room, board, and regular curriculum expenses associated with the academic, therapeutic, and discipleship classes in the residential portion of the program. Teen Challenge Adventure Ranch (TCAR) provides student uniforms, a tablet or laptop computer, and many other personal items while he is in the program. We also provide your child with a monthly allowance that allows him to buy snacks and other items from our campus store.

The residential portion of the program takes 9-12 months to complete. The program can be completed in 9 months; however, this is rare. The average student completes the program in just under 12 months. Please note that for the cash discounted rate, there is no difference in price for students regardless of whether they take 9 or 12 months to complete the program.

Aftercare Services

Initial TCAR also offers an additional 6 months of supportive aftercare services after your child successfully completes the in-residence portion of the program. There is **no additional charge** for these services. These services are optional and do require student and family participation.

25% Discount for Payment in Full

Initial Parents/Guardians who pay in full upon admission shall receive a **25% discount** which is an **\$18,000 savings**.

Deferred Payment Plans

Initial Parents/guardians are expected to pay in full upon admission. If a parent/guardian is unable to pay in full, they may take advantage of our Deferred Payment Plan which allows them to pay tuition in installments over time. Parents/guardians who wish to take advantage of the deferred payment plan must receive prior approval from TCAR and will be required to set up an automatic debit of a credit card or bank account. All payment plans/schedules must be worked out with the admissions counselor prior to their child's admission into the program. It is highly recommended that parent/guardians seek financing outside of Teen Challenge in order to secure the \$18,000 tuition discount.

Refunds

Initial

Overpayments - Refunds of accounts wherein there has been overpayment or there remains excess funds in the account after an account has been credited will be made within 60 days.

Early Withdrawal/Termination - Upon withdrawal/termination, all amounts due to TCAR are payable in full. No refund is given for fees and other miscellaneous charges.

Full Payment Refunds

Tuition that has been paid in full by the parent/guardian is refundable based on the following schedule:

- Within 7 days of entry - 90% tuition refund = \$48,600
- Within 30 days of entry - 80% tuition refund = \$43,200
- Within 60 days of entry - 70% tuition refund = \$37,800
- Within 90 days of entry - 60% tuition refund = \$32,400
- Within 120 days of entry - 50% tuition refund = \$27,000
- Within 150 days of entry - 40% tuition refund = \$21,600
- Within 180 days of entry - 30% tuition refund = \$16,200
- Within 210 days of entry - 20% tuition refund = \$10,800
- Within 240 days of entry - 10% tuition refund = \$5,400
- After 240 days - No Refund is given

Deferred Payment Account Credit

Those that are paying their child's tuition by deferred payment shall receive statement credit on their account based on the following schedule.

- Within 7 days of entry - 90% tuition refund = \$64,800
- Within 30 days of entry - 80% tuition refund = \$57,600
- Within 60 days of entry - 70% tuition refund = \$50,400
- Within 90 days of entry - 60% tuition refund = \$43,200
- Within 120 days of entry - 50% tuition refund = \$36,000
- Within 150 days of entry - 40% tuition refund = \$28,800
- Within 180 days of entry - 30% tuition refund = \$21,600
- Within 210 days of entry - 20% tuition refund = \$14,400
- Within 240 days of entry - 10% tuition refund = \$7,200
- After 240 days - No Refund is given

Monies Due After Credit Has Been Applied

A refund will be issued only in the event that excess funds remain in the account after the above early withdrawal/termination credit has been applied. In the event that there are still monies due after the credit has been applied to their child's account, the parent/guardian will be responsible to continue making deferred payments until the entire remaining account balance has been paid in full.

Special Activities

Initial

There will be **no additional charge** for normal recreational activities. These activities as well as meals are provided by TCAR. Occasionally, students will have opportunity to take part in special recreational or ministry oriented outings. Missions trips are the most common special activity for which there may be an extra fee. Parents/Guardians will be expected to cover the costs for their child to attend these extra events. These extra trips are planned many weeks/months in advance and are optional to students. Parents will be notified well in advance of these additional cost activities.

Transportation Charges

Initial

There are no additional charges for transportation for regular program travel and activities. There is a 50 cents per mile charge (\$20 minimum) to and from TCAR for all transportation of students which is not directly related to normal program activities. Examples of trips wherein a fee will be charged include: doctor visits, dentist appointments, transportation to airports or bus stations, etc.

Shipping Fees

Initial Parent(s)/Guardians(s) shall be responsible to pay a \$20 handling fee plus the actual cost for shipping on any items requiring shipment from TCAR. This fee must be paid in advance (prior to the shipment of any items).

Expenses incurred by TCAR on behalf of the student

Initial Parents/guardians must pay all costs and expenses incurred by TCAR in obtaining medical, psychological, and/or psychiatric treatment, and other care for their child that is not already provided by TCAR as a regular part of the program. They must also reimburse TCAR for any and all claims, damages, miscellaneous expenses, or transportation costs incurred and for any penalties or fees associated with the minor.

Delinquent Accounts

Initial It is the policy of TCAR not to ship items, release grades, or release records to parent(s)/guardian(s) or other agencies unless that student's account has been paid in full.

Fees Billed Outside of TCAR

Initial While your child is at TCAR, he may incur expenses which will be billed by companies, physicians, etc. outside of TCAR. Many of these will bill your insurance company for their services. Examples include but are not limited to: Drug Screenings, Doctors visits, Psychiatric Appointments, Emergency Room visits and/or hospitalizations, Dental and orthodontic work, Medications and/or medical equipment needs.
